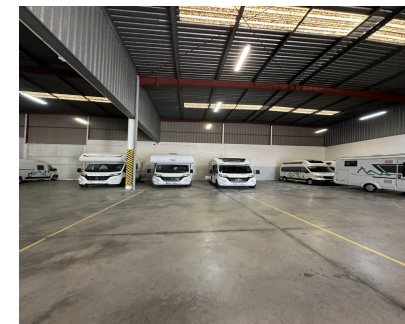
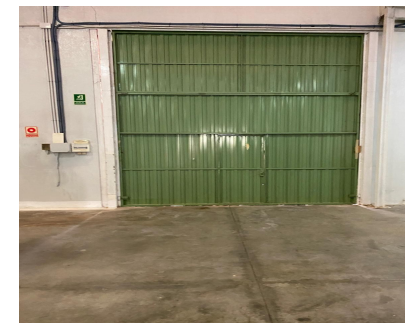

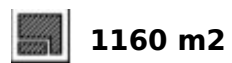

All this in an unbeatable location, with excellent connection to the N-340 highway and public transport through bus lines 5, 9, 10, A, M-110, M-112, M-113, M-132, M-133, and M-230, facilitating access from Malaga city center, the airport, Torremolinos, Benalmadena and other nearby destinations. The last activity carried out in the warehouse was the rental of motorhomes, caravans, RVs, and it has the permission of the city council to continue with this activity or others that you wish to undertake.
